

Award of Honor

The Award of Honor, the highest award given by the Academy of Rehabilitative Audiology, is presented in recognition of sustained and dedicated service and meritorious contributions to the Academy and to rehabilitation of deaf and hard-of-hearing individuals in general. Persons nominated for the Award must have been a member of the ARA for a minimum of 5 years and have served the ARA in three or more of the following ways: as officer, committee chairperson, committee member, or member of the editorial staff of the *Journal of the Academy of Rehabilitative Audiology (JARA)*; through involvement in legislative activity on the state and national level to benefit deaf and hard-of-hearing people; by contributing papers to the *JARA*; or by presenting short courses or papers at Academy meetings. WHEREAS, he served as president of the Academy of Rehabilitative Audiology in 1978, and

WHEREAS, he has authored six publications in the *JARA*, and

WHEREAS, he has presented five papers at ARA Summer Institutes, and

WHEREAS, he served as chair of the *ARA Executive Committee Procedures Handbook* Committee, 1981-1982, and co-editor for this *Handbook* (1983), and

WHEREAS, he encouraged and supported many National Technical Institute for the Deaf faculty to attend ARA Summer Institutes and become ARA members, and

WHEREAS, he is recognized nationally as a clinician, educator, and researcher, and

WHEREAS, Dr. Johnson's activities within the Academy of Rehabilitative Audiology have been continuous and exemplary throughout a period of 19 years; therefore

RESOLVED, that the Award of Honor of the Academy of Rehabilitative Audiology be presented to Dr. Donald D. Johnson for dedicated service and meritorious contributions.
