## The ARA Summer Institute July 6-8, 1977

The annual ARA Summer Institute is scheduled to take place on July 6-8, 1977. This year the Institute is dedicated to our late president, Dr. Janet Jeffers, and has been organized around the central theme, "Hearing Aid Evaluation and Follow-up Procedures." Hopefully, this topic will stimulate ARA members and other Institute participants to consider the strengths and/or weaknesses inherent in procedures currently utilized in various clinical environments around the country. In keeping with the stated purposes of the Academy, to provide a forum for the exchange of ideas, and to foster and stimulate professional education in all aspects of habilitative and rehabilitative audiology, several of the invited speakers will present papers not specifically related to the central theme.

The site of the 1977 Summer Institute, Allerton House, is a restored turn-of-the-century mansion, used by the University of Illinois as a conference center. Located twenty-six miles from campus in scenic Monticello, Illinois, it is close to major transportation, yet far enough away to provide adequate isolation.

Allerton House is surrounded by extensive formal gardens which create a magnificent setting for the nearby 100 free standing sculptures representing many styles and periods. Beyond the formal gardens are 1500 acres of wooded parkland, dotted with sculptures in lead, marble and bronze.

The meals served at Allerton House are superb, and sufficient in quantity for the greatest appetite. Lodging is dormitory style with two to six persons per room. Guest housing at Allerton House is limited to approximately 100 persons and, is thus, reserved on a first-come, first serve basis. Other accommodations for persons with personal transportation may be obtained at motels and hotels in Champaign-Urbana, Illinois.
